Milliken Native Shines Bright as Rising Star in Local Politics

This has resulted in widespread employee turnover, which costs the county. Other indicators of poor leadership include high wait times in the motor vehicle department and poor customer service to the residents of Weld County. These issues are unacceptable.

The County Clerk's office is also responsible for working with the County Commissioners to redraw their own district boundary lines. The redrawing of lines is done every few years adjusting for rapid population growth instead of after each census. Velasquez will be a strong

advocate for complete transparency in the redistricting process and returning accountability to the people of Weld County, ending any temptation for gerrymandering.
